
MARSP NOVEMBER 2025





James Beauchamp, Executive Director of MOTRAN, spoke at the November 6th meeting of MARSP. MOTRAN is the Midland-Odessa Transportation Alliance and is instrumental in raising funds for the infrastructure of the Permian Basin. James explained that the infrastructure includes not just roads and highways, but also pipelines, railways, freight, and air travel. He talked about the development of I-14 and I-27 which will affect the Midland-Odessa area.

These successes have been due to the strength of TRTA's membership.
